## Church Van Policy

### Policy for Riders

- Riders must be at least 4 years old, potty-trained, and have a permission form signed by a **PARENT** or **LEGAL GUARDIAN** in order to ride regularly with us to church.
- All riders are expected to honor God, love others, and respect authority. Failure to do so will result in suspension.
- Toys, games, and electronic devices should be left at home. Riders may bring phones as long as they're **turned off** when arriving at the church.

### Policy for Transportation

- The Van Director contacts riders to see who needs a ride to church. To attend the Wednesdays service, the director needs the info by 4PM on Wednesdays. To attend the Sunday morning service, the director needs the info by 7PM on Saturdays.
- If riders are minors, they must be dropped off at the place they were picked up unless the parent tells the van director otherwise. This is to ensure the safety of the child.

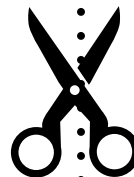
